4. Information required by members:

Any member of the society may apply to the Secretar for any information as he may require on any matter on the objects or Rules and Regulations of the society.

5. General and other meetings:-

1. General Body of the society will be held annually during the month of January.
2. The Report of the Management on the previous year's working and the Audited Accounts for the same period and proceeding year shall be discussed and submitted for the confirmation to the Registrar of Societies.
3. A new committee for the subsequent year shall be constituted in the General body meeting.
4. The committee shall generally meet once in six months for which a clear notice of 7 days will be given to the Members by the Secretary.
5. President ^{shall} call for Annual meeting if ~~he desired and it shall be on the request of 25% of the Members~~ for which 7 days clear notice shall be given to members.
6. For election of members, voting shall be conducted by show of hands or by secret ballot.

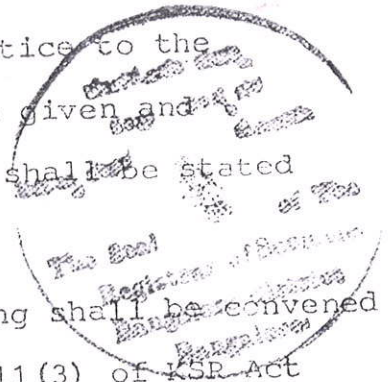

7. 21 days clear notice given to the ordinary meetings and 21 days clear notice to the General Body Meetings will be given and the subjects to be discussed shall be stated in such notice.
8. A special General Body Meeting shall be convened if necessary as per Section 11(3) of KSR Act 1960. An Auditor shall be appointed annually and the Remuneration shall be fixed by the Members in the General Body Meeting.



6. Accounts:-

- 1) The official year of the society shall be from April to the end of March every year.
- 2) The Assets and Liabilities and the Balance Sheet of the society shall be drawn by the Auditor duly audited and shall be laid before the Annual General Body Meeting for confirmation.
- 3) Such balance sheet and the list of committee members shall be filed with the Registrar of Societies as per Section 13 of KSR 1960.

7. Executive powers of the Committee:-

The Administration and the Management of the Society shall vest with the Executive Committee consisting of seven members including president and the Secretary elected at the Annual General Body Meeting of the Society subject to control of the Society in General.

1) President:- He/she shall Act as Chairman in the Committee. In ^{his} absence members may elect any ^{one} of the Members as Chairman.

2) Secretary:- He/she shall have charge of all materials belonging to the society with the exception of those pertaining to Accounts and he/she shall be executive officer of the society and he/she shall be executive of the society. He/she shall sign all the Routine Letters and pass all the Bills and the cheques made out. If the secretary is absent the president can sign the cheques.

g) To ensure that all monetary - transactions are through scheduled Banks.

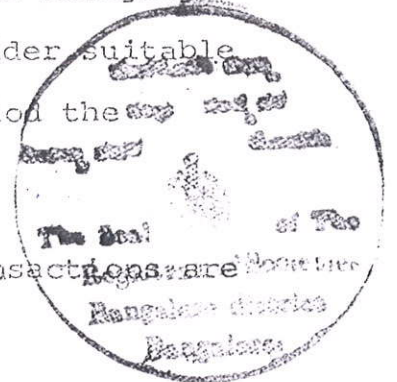
h) To ensure utilisation of Income towards promoting the objectives of society.

m) Managing Committee may appoint a committee/ sub committee with such powers as deemed fit by this body for the purpose of incommensurate with objectives. The committee, sub-committee may co-opt persons who are members of the society.

n) Managing Committee may invite to their meeting not more than two specialists/Experts who may be Non members of the Association whose society with deliberations if considered useful.
